PLEASE NOTE THE FOLLOWING IN ORDER TO APPLY FOR A FREE OR REDUCED BUS PASS:

- Applicants must apply in person at IUSD Transportation Office.
- Applicants must complete an Income Verification Form and bring supporting documentation.
- Applicants must bring the 2008 Federal Income Tax Form return.
- Applicants must bring 2 current paycheck stubs from each working adult.

If you did not file a Federal Income Tax Form, you will need proof of:

- Current bank statement-2 months.
- Letter from your employment stating your hourly rate of pay and how many hours per week you work.
- If you are unemployed you must bring a letter from EDD that show how much you are awarded monthly.
- If you receive welfare, you need to attach the form from the Welfare Department with your case number on the document.
- If you receive SSI income (Social Security) Verification paper of SS payment last 2 months, letter from your employer, letter from you as the parent/guardian stating your circumstances.
- Each semester the applicant must reapply and bring new current proof of income.
