IHS BEHAVIORAL CODE

Care and concern for the safety/welfare of Irvine High School students has prompted the development of this agreement. All students attending an Irvine High School activity, on or off campus, are expected to know that appropriate behavior is required and that all school rules are enforced at any activity sponsored or supported by Irvine High School. Activities include, but are not limited to dances, athletic events, senior activities, banquets, pep rallies, performing arts events, camp, field trips, lunch activities, etc. All students and parents, please be aware of the following specifics regarding school activities:

- To gain admittance to an event, each student must have an **Irvine High School ID Card**. If the student does not have an ID card, he/she must get a duplicate (at a \$5.00 fee) from the Activities Office prior to the event.
- Once a student leaves an event, he/she may not return. No student will be admitted to an event after 10:00 PM.
- Bids/tickets are not transferable from student to student and there are no refunds after an event has taken place.
- Students will be warned of any inappropriate behavior (i.e. inappropriate dancing) and if student does not comply with the request, they will be asked to call their parents and leave the dance. Please see attached Dance Code.
- Any student found to be "under the influence" or in possession of alcohol or any other controlled substance at a school activity will be removed and parents will be notified. Student will then be suspended for five school days and excluded from all school activities for an additional ten school days. An additional three days of substance-abuse counseling is mandatory. Parent participation is required.
- A student may be charged with possession, if alcohol or any other controlled substance is found in a vehicle in which the student is a passenger, even if the substance is in a sealed container.
- For a second offense, the student will be removed from Irvine High School.
- When dances allow for guests, each non-Irvine student must fill out a guest pass form. This form must be turned in to the Activities Office when tickets are purchased (All guests are required to show a photo ID at the door and must be under the age of 21). All Irvine students sponsoring a guest are responsible for the behavior of their guest. See attached Guest Policy.

BY SIGNING THIS AGREEMENT, the student and parent acknowledges awareness of these conditions and accepts the responsibility to attend any and all school activities free from the influence of any controlled substance.

"I understand all school events are drug, alcohol, and tobacco free. I, along with any guest I may bring, agree to remain drug, alcohol, and tobacco free at all school events. Furthermore, I have read and understand the above rules pertaining to student conduct at school events and I understand the consequences for any inappropriate behavior."

IRVINE HIGH SCHOOL DANCE CODE

In accordance with the Irvine High School values of Integrity, Honor Self and Others and Social Responsibility, the Irvine High School staff will enforce appropriate dance behavior at all school dances.

The following behaviors are prohibited:

Any action that could be construed as "freaking"
Riding, straddling or grinding in any way
Sexually suggestive front to back dancing
Dancing in a bent over position

(After 1 Warning) Violation of this Dance Code will result in:

Immediate removal from the dance
Future dance privileges being revoked
Parent contact
No refund of ticket expense

Guests: It is the IHS student's responsibility to be certain that their guest is behaving according to these expectations.

TO PURCHASE TICKETS FOR AN EVENT:

All fees and fines must be paid in full one week prior to purchasing any dance tickets. You must have your ID Card in your possession at the time of purchase. NO EXCEPTIONS! Irvine students must have a permission slip on file. (Or parents must sign a new slip)

Guest MUST have a signed permission slip, which may be found on the reverse side of this form. Please bring both student ID's to the event along with your receipt. Only guests over the age of 13 and under the age of 21 will be admitted to the event.

IRVINE HIGH SCHOOL DRESS CODE

The IUSD Board Policy states:

“All students of the Irvine Unified School District shall attend school and school activities dressed in a manner that is conducive to and promotes a positive learning environment. Appropriate school dress and personal appearance are clean, are not hazardous to student safety, and do not disrupt instruction.

Freedom of expression is a right guaranteed all Americans. Each student’s dress and personal appearance is, within certain limits, a matter of personal style and individual preference. However, decisions concerning appropriate school dress and personal appearance should occur in partnership with students, parents, and school to assure the greatest opportunities for student success.

Appropriate dress and personal appearance at school and school-related activities shall not include any clothing, attire, or accessory that by its manner of appearance, arrangement, trademark, fit, or any other unsafe; disruptive; unhealthful; obscene, profane; ethnically, racially or sexually degrading; libelous or slanderous; exposing undergarments; provocative or revealing; advocating unlawful behavior or illegal substances; or suggesting or promoting any affiliation with any street gang or other group that commits unlawful acts.”

Current examples of inappropriate dress include, but are not limited to, the following clothing, attire, apparel and accessories.

DANGEROUS, DISTRUPTIVE, PROVOCATIVE OR REVEALING

| Clothing considered undergarments | Dress/Skirt must be no shorter than fully extended fingertips |
| Clothing exposing undergarments | Dress/Skirt slits may be no higher than fingertip length |
| Clothing exposing midriff, upper torso, etc. | Backless garments must not extend below the waist |
| Halter tops (exposing front or back) | Tops must not be excessively low cut |
| See through dresses / bare sides | Shoes must be worn at all times |
| Mini-skirts that do not cover appropriately | Bandanas / chains / canes are prohibited |

SUGGESTING/PROMOTING STREET GANG AFFILIATION OR OTHER UNLAWFUL ACTIVITIES

- Any combination of clothing which, upon guidance from law enforcement agencies, is considered gang-related (these may change, i.e. bandanas, hair nets, metal belt buckles with gang-style monograms, dangling belts, chain accessories, slippers). Also prohibited is any reference to illegal or controlled substances.

RAVE PARAPHERNALIA - Per district policy, no glow sticks, glowing mouthpieces, beads, flashing lights or pacifiers will be allowed into the dance. If paraphernalia emerges during the dance, paraphernalia will be confiscated.

GENERALLY, if you look in the mirror and you can see parts or all of your underwear, you need to change your clothes before you come to school/events. Bare midriffs, low cut tops, halter tops, spaghetti straps that leave bra straps showing, swimwear, and muscle shirts that show “too much muscle” are not allowed. If you exhibit wisdom in your dress choices, infractions will be of little or no consequence.

Students who come to school inappropriately dressed will face disciplinary measures, which include:

- Wearing a “loaner” shirt and issuance of two (2) hours of detention
- Possible parent contact to deliver appropriate attire to school

Students’ use of good judgment and common sense is essential. It is best to error on the side of caution when choosing your actions & attire. Dances and other IHS Activities are intended for your enjoyment. Why run the risk of missing out due to an unwise choice?
