School Description and Mission Statement (School Year 2009-10)

Stonegate Elementary School is a family-friendly school, where children and learning are our first priorities. We have a strong sense of purpose and provide a stable, secure environment where parents and families feel at home and know their children will receive the best possible education.

We are committed to educating the "whole child" through a strong academic focus on the state content standards in each subject area, curriculum consistency among grade levels, high behavior standards, and consistent discipline. In addition, we help prepare students ethically, socially, and technologically for success in our global society.

We are in our inaugural school year as Stonegate Elementary. Our brand new facility is located in the northeastern

area of Irvine. We serve the communities of Stonegate, Portola Springs and Woodbury. The majority of our staff and students attended formerly [the now closed] Westwood Basics Plus School.

In 1998 Westwood received the California Distinguished School Award from the California State Department of Education. We are very proud that Westwood Basics Plus School was named a U.S. Blue Ribbon School by the United States Department of Education in 1999. Educators from other school districts and a representative from the federal Department of Education based this award on parent and staff input, a thorough analysis of our educational program and processes, test scores, and a site visit to our school.

Now as Stonegate Elementary we continue to focus on the needs and development of students. We are an eco-friendly Green school and utilize the latest technology to enhance learning throughout the school. Each classroom is equipped with a document camera, airliner and LCD projector. In our multi-media center, computer lab areas and library students enjoy access to advance technology tools as well. Grades 4-6 have implemented the Irvine On-Line Assessment (IOLA) program to assess students on achievement of the California State Content Standards in academic areas. Students K-6 have regular instruction in technology and its application to learning.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics, and science in grades two through eleven, and for science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades three through eight and science in grade five and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. For example, the NAEP only assesses grades four, eight and twelve and for long-term trends assesses grades nine, thirteen, and seventeen. Additionally, the NAEP only provides state test results for grades four and eight. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
