School Description and Mission Statement (School Year 2007-08)

This section provides information about the school's goals and programs.

Westwood Basics Plus Elementary School, located in the village of Northwood, enrolled just over 400 students for grades K-6 during the 2007-08 school year. English-speaking students made up the majority of the student population; however, a number of minority students represent a variety of ethnic backgrounds and speak many different languages.

Westwood Basics Plus School is a family-friendly school, where children and learning are our first priorities.

We have a strong sense of purpose and provide a stable, secure environment where parents and families feel at home and know their children will receive the best possible education.

We are committed to educating the “whole child” through a strong academic focus on the state content standards in each subject area, curriculum consistency among grade levels, high behavior standards, and consistent discipline. In addition, we help prepare students ethically, socially, and technologically for success in our global society.

In 1998 Westwood received the California Distinguished School Award from the California State Department of Education. We are very proud that Westwood Basics Plus School was named a U.S. Blue Ribbon School by the United States Department of Education in 1999. Educators from other school districts and a representative from the federal Department of Education based this award on parent and staff input, a thorough analysis of our educational program and processes, test scores, and a site visit to our school.

Westwood has continued to focus on the needs of students and to make changes as needs arise. In the area of technology, we installed multi-media instructional centers in each grade 1-6 classrooms. Toward this effort, we also have two computer labs, one equipped with 35 computers and another with 20 computers. Grades 4-6 have implemented the Irvine On-Line Assessment (IOLA) program to assess students on achievement of the California State Content Standards in academic areas. Each classroom also has at least one PC computer and LCD projectors have been installed in many classrooms. Students K-6 have regular instruction in technology and its application to learning.

Policy Relating to School Dress Code (especially gang-related apparel), 2g. Procedures for Safe Ingress and Egress of Pupils, Parents, and School Employees To and From School, 2h. Procedures that Create a Safe and Orderly Environment Conducive to Learning at School, 2i. Rules and Procedures on School Discipline.

Facility Conditions and Planned Improvements (School Year 2008-09)

During the 2001-2002 school year, Westwood Basics Plus was repainted on all exterior and interior walls. A new roof was completed. Numerals were placed on the doors in accordance with the building blueprints and a security pad system was installed for safety/security purposes. In 2002-2003 stained ceiling tiles were replaced and areas of the blacktop were patched. During the summer of 2004, the parking lot was re-surfaced and all of the traffic pattern lines and curbs were repainted to assure safety. Sand beneath the swing set was replaced with wood chips and a sidewalk used by the kindergarten children was curved away from a main access sidewalk to ensure their safety. In 2005-06, the parking and traffic pattern in our parking lot was studied, evaluated, and updated in a joint effort between IUSD and the Irvine Police Department to ensure safer ingress and egress for our students (and our parents). At the same time speed bumps and additional parking spaces were added in an effort to alleviate traffic congestion.
